At this time the Woodstown-Pilesgrove Regional Board of Education will be accepting applications for subscription busing to and from Mary S. Shoemaker School (Grades 1 through 5) for the 2016-2017 school year, however, the number of available seats is limited.

The fee is \$573.12 for the year (to and from school) or \$286.56 per run (AM or PM run only). **The district reserves the right to cancel your subscription and return your fee (prorated) in the event that the seat is needed to transport students that are mandated by State law and Policy.**

Families who meet the criteria for subscription busing and also meet the criteria for free and/or reduced lunches shall have subscription fees waived pending verification of eligibility.

If interested, please complete the enclosed form and return it to the Transportation Office no later than Friday, July 8, 2016. At that time, all requests will be reviewed and seats assigned as available. If we are able to accommodate your request, you will be notified by our Transportation Office by Friday, August 12, 2016.

Please note that Kindergarten students will continue to be transported by the District.
