


General Meeting





- iv. MSS Playground - Mrs. Cioffi wanted to update us about the MSS Playground condition mentioned on the social media site. She shared with us that every year, a company comes out to inspect the equipment and they are structurally sound. Every year, 2 members from maintenance weld and epoxy the rusty parts for safety purposes. Due to Covid, this process did not happen as normally planned. They currently have it roped off with caution tape to protect our students. As the PTO, we set aside the maintenance reserve to help the maintenance or replacement cost. The playground was purchased by the PTO 25 years ago and at some point pieces may need to be replaced. Jessica mentioned that value was around \$500, but she will verify in her records. Mrs. Cioffi mentioned that she would like to get a plan in place to help cover the maintenance cost. We will discuss options down the road to put a plan in place for when that time comes. Mrs Hildbrand and Mrs. Cioffi have been getting quotes. If we were needing to replace the main piece, it can cost up to \$20,000.
